Your policy includes requiring strong, unique passwords or pass-phrases and encourages the use of a password manager.</p> 	<input type="checkbox"/> <b>MULTI-FACTOR AUTHENTICATION</b> <p>You have enabled multi-factor authentication (MFA) for all users on all accounts for which it is available.</p> 	<input type="checkbox"/> <b>PATCHING &amp; UPDATES</b> <p>All computers, systems, and software are on regular patching schedules that you audit regularly to ensure patching compliance.</p> 	<input type="checkbox"/> <b>ANTI-VIRUS (ENDPOINT PROTECTION)</b> <p>You use an organization-wide anti-virus solution on all Windows and macOS computers that provides advanced protections including anti-malware, network protection, and content control capabilities.</p> 
<input type="checkbox"/> <b>FIREWALL &amp; UTM</b> <p>You have a firewall in place for all of your networks that segregates trusted and non-trusted networks, provides objectionable content filtering, and includes other unified threat management (UTM) features.</p> 	<input type="checkbox"/> <b>BACKUPS &amp; BUSINESS CONTINUITY</b> <p>You have a robust local <i>and</i> cloud-based backup schedule. The technical portion of your broader business continuity plan is clear and understood by your IT team. Leadership is aware of recovery capabilities and timelines.</p> 	<input type="checkbox"/> <b>USER MANAGEMENT</b> <p>You regularly delete old user accounts that are no longer in use. You follow a standard process for new users that ensures 'least access' privileges with appropriate management approvals required for access level changes.</p> 	<input type="checkbox"/> <b>SECURE WI-FI &amp; NETWORK</b> <p>You employ network segmentation. All private networks are password-secured, and client-isolation is enabled for all public/guest networks.</p> 
<input type="checkbox"/> <b>ENCRYPTION</b> <p>You have full-device encryption enabled on all Windows and macOS workstations. Users are trained on properly encrypting emails containing sensitive information.</p> 	<input type="checkbox"/> <b>ANTI-PHISHING &amp; EMAIL SECURITY</b> <p>You have an organization-wide anti-phishing and email security solution, such as IRONSCALES, that provides added protection against phishing, name spoofing, and other email-based threats.</p> 	<input type="checkbox"/> <b>SECURITY AWARENESS TRAINING</b> <p>You consistently provide ongoing training for your staff (periodic online modules, webinars, group training sessions, etc.).</p> 	<input type="checkbox"/> <b>ENDPOINT MANAGEMENT &amp; SECURITY</b> <p>You have tools and processes in place to accurately track your endpoints (computers). You utilize additional features of your management platform to implement security policies, security auditing, and ransomware monitoring and protections.</p> 
<input type="checkbox"/> <b>ENDPOINT DETECTION &amp; RESPONSE</b> <p>You use an endpoint detection and response (EDR) tool, like Huntress, installed on all servers and workstations, to automatically scan for threats that anti-virus might miss.</p> 	<input type="checkbox"/> <b>VULNERABILITY SCANNING</b> <p>You conduct regular (monthly), automated vulnerability scanning of your organization's network.</p> 	<input type="checkbox"/> <b>CYBERSECURITY INSURANCE</b> <p>Unfortunately, this is no longer optional for a secure environment.
